## **Privacy Policy for 10DLC Messaging Services**

#### Introduction

The Accessory Shop, LLC ("we," "us," or "our") is committed to protecting your privacy and ensuring the security of your personal information. This Privacy Policy explains how we collect, use, disclose, and protect your personal information when you use our 10DLC messaging services (the "Service").

### **Information We Collect**

We collect various types of personal information from you when you use our 10DLC messaging services, including:

- **Phone Number:** We collect your phone number to send you text messages, notifications, and other communications via our 10DLC messaging service.
- Message Content: We collect the content of any messages you send or receive via our Service.

  assist us in operating the Service, such as messaging platforms or analytics providers.
  These providers are required to keep your information confidential and use it only for the
  services they provide to us.
- **Marketing & Promotional:** We do NOT sell or share your information with any third party entity for any kind of marketing or promotional materials.
- **Legal Requirements:** We may disclose your information if required to do so by law or in response to valid requests by public authorities (e.g., a court or government agency).
- Compliance with 10DLC Regulations: We may share data with telecommunications
  carriers and regulatory bodies as needed to comply with 10DLC messaging standards
  and requirements.

#### **Data Retention**

We retain your personal information only as long as necessary to fulfill the purposes outlined in this Privacy Policy or as required by law. We will retain your message content and related data for auditing and compliance purposes as required by 10DLC regulations.

## **Your Rights and Choices**

You have certain rights regarding your personal information, including:

- Opt-Out: You can opt out of receiving 10DLC messages at any time by replying "STOP" to any message you receive from us. This will stop all future communications via 10DLC.
- Access and Correction: You may request access to the personal information we hold about you and request corrections if necessary.
- **Data Deletion:** You may request that we delete your personal information, subject to legal and regulatory requirements.

# **Data Security**

We take reasonable steps to protect the security of your personal information, including encryption, access controls, and other security protocols. However, no method of transmission over the Internet or mobile networks is completely secure, and we cannot guarantee absolute security.

## Children's Privacy

Our Service is not intended for use by individuals under the age of 13. We do not knowingly collect personal information from children under 13. If you are a parent or guardian and believe

we have collected personal information from your child, please contact us, and we will promptly address the issue.
